We stand with Ukraine: How you can help

Mendip District Council stands with those affected by the conflict in Ukraine. Many residents in the district want to help support the humanitarian response. The Council is not collecting donations directly, but we've compiled a list of support organisations.

- **Disasters Emergency Committee** Ukraine humanitarian appeal
- The Red Cross has set up the <u>Ukraine Crisis Appeal</u>, which is requesting donations to respond to humanitarian needs through food, water, first aid, medicines, warm clothes and shelter
- **UNICEF** is especially concerned for the safety and wellbeing of children and has set up a specific fund to protect children in Ukraine
- The UN refugee agency helps refugees fleeing situations of war and has a specific collection for Ukraine.
- The Ukrainian Embassy has set up a special fund to support Ukraine
- <u>Polish Humanitarian Action</u> is supplying hygiene products, food, and blankets to those in need on the Ukrainian/Polish border.
- London's Ukrainian Institute also has a round-up of support methods here.
- UN Women is working to ensure that women and girls' rights are upheld during times of peace, and now, in this frightening time of war - <u>Support</u> women in Ukraine - UN Women UK
- Care International is running an emergency appeal to provide emergency food and water.

New section of multi-user path in Dulcote open

A new section of a multi-user path in Dulcote was officially declared open at a special celebration on 4th March 2022.



It marked the latest stage in a key section of the Strawberry Line which forms part of the Somerset Circle, now in construction. The path connects Wells to the Charlie Bigham's food kitchen at Dulcote quarry.

Volunteers, plus landowners Somerset County Council, Charlie Bigham's, the planning applicant Greenways, Cycleroutes, and officers and members from Mendip District Council, were thanked for their efforts on the path, which is now ready for all to enjoy. Additional planting, landscaping and benches are to be installed shortly. The Council invested £70k towards the works which were commissioned by Greenways and Cycleroutes, as well as a further £15k from Charlie Bigham's S106 money.

The Strawberry Line is part of the Somerset Circle which, when completed, will form a 76-mile traffic-free circuit. Learn more about the project here:

Top ten performance ranking for Mendip as it tackles climate change

Mendip has been recognised as a top ten District Council for its impressive performance in tackling climate change. Campaign group Climate Emergency UK ranked Mendip an impressive 9th best District Council in the whole country. Your local Council was awarded 71% overall, with top marks in mitigating and adapting to climate change, understanding the co-benefits of climate action along with the risk of inaction, and our commitment to tackling the ecological emergency.

Climate change projects Mendip has recently been working on include:

- Launching a £50k Climate Emergency Fund which will provide 14 projects across the district with money to work towards eco initiatives in the community.
- Working in partnership with the AONB, Reimagining the Levels and Somerset Wildlife Trust to help plant nearly 7000 trees, restore hedgerows and protect biodiversity.
- Partnership working with the Centre for Sustainable Energy and the other Somerset Authorities to deliver Green Homes Grants to help improve energy efficiency and decrease the carbon footprint of homes in Mendip.
- Developing additional planning policies to ensure new housing developments are more sustainable and energy efficient.
- Working on a project to better understand the emissions from agriculture and how these can be mitigated and reduced.
- Reporting annually on our own civic emissions as well as monitoring and reporting on emissions across the district.
- Expanding the Strawberry Line multi-user path, to ensure safe, sustainable travel for residents and visitors to Mendip.

Mendip announces successful Climate Change projects

The projects that have been awarded money from the Mendip Climate and Ecological Emergency Fund, have now been announced.

Mendip set to transfer ancient asset to Wells community

The historic Bishop's Barn and Wells Recreation Ground are to be returned to the City of Wells. At a meeting of Mendip District Council's Cabinet (Monday 7th February), members approved the transfer of trusteeship of the Wells Recreation Ground charity to Wells City Council. At transfer, Mendip District Council will no longer have any legal or financial responsibility for the Trust.

Changing the governance of the charity is legally complex, and the process has taken many months to complete. However, subject to Charity Commission authorisation, the move means Wells City Council are all set to become the new 'caretakers' of the Bishop's Barn and Wells Recreation Ground, located in the heart of the city.

Mendip previously agreed a budget of up to £5,000 to cover legal costs involved in transferring the trusteeship. The Trust Fund of circa £525,000 capital money is included in the transfer, and this is solely to be used to improve the Bishop's Barn. In addition, a one-off payment of £30,000 will also be made to the Trust by Mendip, which is equivalent to six years of average income from 6 car parking spaces in South Street Car Park.

After the transfer, Mendip District Council will continue to own, operate, and maintain the car park as part of its normal operations.

Mendip helps fund restoration of Shepton Mallet memorial

Mendip District Council has contributed £5,000 towards the restoration of an important historic monument. The James Allen obelisk in Shepton Mallet Cemetery, was crumbling, in disrepair and needed urgent attention. The new-look memorial, which stands 3m tall, was unveiled at a special ceremony during this weekend's annual Snowdrop Festival.

The James Allen Family Memorial is an important part of the town's heritage, which honours the life and works of the world-famous horticulturalist, who bred speciality snowdrops. Work to restore the 116-year-old monument was carried out by local stone mason, Sam Lee of SK Conservation, who specialises in carving, fixing and building conservation, Amelia Crowley-Roth, wood carver and Andy James who engraved the lettering on the obelisk.

The monument was unveiled by Dan Pearson, Snowdrop Festival Patron and committee member. Among the guests were, Her Majesty's Deputy Lieutenant for Somerset, Tim Allen, Dr Tim Upson from Royal Horticultural Society, Christina Kennedy, Chair of the Snowdrop Festival and representatives from Mendip District Council, including the Council Leader.

Consultation

Have your say on unauthorised van dwellers in Glastonbury

Residents are being invited to take part in a public consultation designed to help address the difficulties that arise from the volume of van dwellers on public roads within Glastonbury and neighbouring areas.

Mendip District Council is considering the adoption of a Public Spaces Protection Order (PSPO) as part of a planned approach to reduce the risk of public nuisance, which continues to cause community tensions in the town.

The introduction of a PSPO would assist the better management of the number of unauthorised encampments and help to restrict or prevent the adverse effects that may be created by the occupations.

The Council wants to restore balance to the area to regain and maintain a sustainable level, and so reduce the impact on local communities, businesses and tourism.

Details of what the proposed PSPO involves, together with the reasons behind why Mendip District Council is considering adopting the order, and a map of the geographical area affected, can be found on our website: www.mendip.gov.uk/pspo All comments must be returned by 20th March 2022 which is the final date of the public consultation.

The PSPO is just one of a number of ongoing initiatives in and around Glastonbury delivering schemes to help prevent unauthorised encampments and parking at Glastonbury locations. A Glastonbury Unauthorised Encampment Multi-Agency Group (MAG) was formed last year to work with communities to explore and agree long-term, sustainable solutions. Membership includes representatives from Avon & Somerset Police, Somerset County Council, Glastonbury Town Council, Avon & Somerset Police and Crime Commissioner and Mendip District Council.

The MAG has supported new double-yellow lining on Wellhouse Lane, and enforcement being employed on key sites in the town to remove vehicles from the road. This was carried out last month at Morlands Enterprise Park. Permanent infrastructure proposals to prevent unauthorised encampments and parking are also being explored at Bretenoux Road.

And at Stone Down Lane, work is taking place to prevent vehicles from parking unsafely on the roadside and create new disabled parking bays for blue badge holders. During the works there's no access to Stone Down Lane, and access to the Tor is only possible from the south side during the works. A signed diversion is in place.

Mendip Homes & Housing

Number of empty homes in Mendip declining

Latest figures from Mendip District Council show the number of empty homes in the district has decreased by almost a quarter. There are currently 392 long-term empty homes (of over 6 months) in Mendip, compared to 509 in April 2020 - that's a drop of 23%. The news comes as the Council takes part in the national Empty Homes Week, 28 February - 6 March. Grants and loans are available from Mendip to support owners in bringing their vacant and derelict properties back into use.

There are grants of between £3,000 and £15,000, and loans of up to £25,000 available to go towards renovation works. And once repaired, it means properties can be rented or occupied by owners.

£49k funding boost to support landlords improve EPC ratings

Mendip District Council, in partnership with the Centre of Sustainable Energy (CSE), have successfully bid for £49,057 to go towards supporting landlords with an Energy Performance Certificate (EPC) rating below Band E, to improve their properties and meet their legal obligations.

The Council and CSE will work together to support Mendip landlords improve their EPC ratings through education, training and events, with the aim of making homes more energy efficient, warmer and cheaper for residents to live in.

Green Homes Grants available for low-income Mendip residents

Residents across Mendip could benefit from free energy efficiency improvements worth up to £10,000 thanks to receiving a share of a multi-million-pound Government-funded Green Homes Grant Programme, working with E.ON and Happy Energy Solutions.

Endorsed by Mendip District Council, under the Green Homes Grants Scheme, owner-occupiers will benefit from energy efficiency installations up to the value of £10,000 with nothing for them to pay towards the costs of works.

Tenants of rented properties can also access grants of up to £5,000 for energy efficiency upgrades, but the landlord will be expected to contribute at least one third towards the cost of works.

To be eligible for the grants, the residents of the property must have a low income (receive benefits or have the household income below £30,000 per annum) and the EPC for the property must be rated D, E, F or G. If there is no EPC for your property, you can still apply, and it doesn't matter who your energy supplier is.

Struggling to pay for your rent? Your Council can help you

Tenants who find themselves struggling to pay for their rent are encouraged to contact Mendip District Council's Housing Options Team for advice and support, as early as possible, to help prevent them becoming homeless.

The Council's experienced and knowledgeable Officers are on hand to assist tenants facing financial difficulties, and find solutions to ensure residents do not become homeless.

Mendip District Council received funding from the Department for Levelling Up, Housing & Communities to create a Tenancy Hardship Scheme. The scheme is ringfenced to support low-income renters, with Covid-19-related rent arrears, through a one-off payment, to reduce the risk of them being evicted and becoming homeless.

Mendip households urged to set up council tax direct debit to receive rebates quickly

Mendip District Council is urging bill-payers to set up a direct debit to pay their council tax from April, to ensure they get their £150 energy rebate payment as quickly as possible. In Mendip, around 76% of households pay by direct debit - but it still leaves more than 12,500 households who do not currently pay their council tax through this convenient arrangement.

Getting the rebate money to council tax payers without a direct debit in place will take longer to process as council staff will need to attempt to contact them about the rebate scheme, and undertake pre-payment checks, resulting in delays.

All eligible households in England in council tax bands A to D, should get the £150 payment from their District Council from April this year.

Opportunity Boost Scheme to open doors to employment

A new grant has been launched to help people in Somerset overcome financial barriers when seeking employment and returning to work.

The Opportunity Boost Scheme will provide grants worth up to £500 to help with the cost associated progressing into work, such as transport costs, childcare, work clothes, learning resources and training courses.

The funding for scheme has been provided through the Somerset Recovery Fund, and the initiative is being delivered in partnership between Somerset County Council and Citizens Advice Somerset.

To qualify, applicants must live in Somerset, be aged 16 or over, not be entitled to any other financial assistance for job seeking, and have a pre-Covid salary of less than £25,000.

Support for the vulnerable

£3.8m to support Somerset households with food and bills

Somerset residents struggling to pay the bills this winter could be eligible for support with the cost of food, energy, water, and other essentials.

Somerset has been allocated £3.8m from the Government's Household Support Fund which will be used to ensure there is a wide range of support available to those who need it between now and the end of March.

Proposals for how the money will be used have been developed by the Community Resilience Partnership, a collaboration between Mendip District Council, Sedgemoor District Council, Somerset West and Taunton District Council, South Somerset District Council, Somerset County Council and partner organisations in the voluntary and community sector. Some £1.7m will be distributed via Somerset Citizens Advice, supported by a network of local partners from the voluntary and community sectors, to help households with food, utility bills, and other essentials.

Budget 2022/23

Mendip's final budget will 'weather the storm' of local government cuts and ensure good quality services for residents

Mendip District Council approved its budget for the next financial year at Full Council last night (Monday 21st February 2022). The budget will be the last ahead of the creation of a new unitary authority in April 2023. It will allow the Council to continue to invest locally in Mendip, improve services and tackle key local issues while also managing the significant loss of funding from the Government.

The proposed budget for 2022/23 allocates resources to priorities identified in the Council's Corporate Strategy, as well as providing a range of services including waste collections, fly-tipping enforcement, and leisure and tourism services.

The District Council's budget is funded through the Council Tax, a share of Business Rates and income from services such car parks, government grants, and its commercial property investments.

Core central government funding reductions during the past decade, are in the region of 60%. Inflationary pressures also have impact (allowances made for inflation in the 2022-23 budget total around £400k). And there are significant increased service costs.

But despite these ongoing financial challenges, Mendip's budget is balanced, and the Council has fully-funded spending plans for the year, prioritising and investing in services and supporting spending on key projects such as social and affordable housing delivery, multi-user paths, a cleaner, greener Mendip, creating energy-efficient homes and encouraging economic development.

It's quick and easy to register to vote, but after the deadline of 14 April, it will be too late.

If you're not registered, you won't be able to have your say on issues that directly affect your day-to-day life in Somerset.

These crucial elections are for the councillors at county level who will oversee the transition to a new unitary council, which they will then lead to deliver all the promises and ambitions of the unitary business case.

The city, town and parish councillors elected have a vital role too, ushering in a new era of community empowerment. They will be pioneers, drawing on an array of new opportunities, driving real change locally.

Pre-election period

The Notice of Election will be posted on 21st March. This means the pre-election period (previously known as purdah) will come into force from **21st March – 5th May.** The period of sensitivity preceding the local elections means particular care should be taken in the weeks preceding the elections - in this case from 21st March.

Consultation on constituency boundaries

The 2023 Boundary Review also requires that the number of constituencies in England increases from 533 to 543. The Commission is holding a secondary consultation on its initial proposals for new constituencies, which takes place from now until 4 April 2022.

The Glastonbury Multi Agency Group (MAG) - update

Improvement scheme to go ahead on road serving Glastonbury Tor

Work on a scheme to improve road safety near the north entrance to Glastonbury Tor is taking place. The Glastonbury Multi Agency Group (MAG) has worked with the National Trust, local farmers, and residents to develop a plan for Stone Down Lane to prevent vehicles from parking unsafely on the roadside and create new disabled parking bays for blue badge holders.

The new infrastructure comprises a bund of earth and boulders placed along a section of the road and work began on Monday 28 February. It'll take three weeks. During this time there will be no access along Stone Down Lane for vehicles or pedestrians - a diversion will be in place. The north entrance to the Tor will be inaccessible during this period.

A community-focused open day event was held on Friday 25th February at the Town Hall in Glastonbury, giving local residents and businesses an opportunity to find out more about the Glastonbury Town Deal projects. Visitors to the event will be encouraged to submit their comments and suggestions on the project proposals, providing input to the Business Case process currently underway. The event showcased the 12 projects that are set to benefit from the £23.6 million investment and highlighting some of the opportunities these could bring for the local community.

The Saxonvale Development - Mendip District Council working with Acorn Property Group

Mendip District Council has taken an exceptionally strong leadership role in the delivery of the Saxonvale project, having committed significant funds and time to it, because of the unique opportunity to assemble the site and promote a scheme which has good prospects for delivery.

All other attempts to assemble the site had failed, and the Council is to be applauded for its courage in bringing the project forward for the good of all communities in the town, its immediate surrounding areas and across the wider Mendip district.

When purchasing the site, the administration considered very carefully how it could ensure that the most attractive outcomes would be delivered, and this included speaking to a number of development companies. There was clear agreement that Acorn had the best track record and vision for delivering a scheme which would create a bespoke and exciting, sustainable and heritage-based living environment for the benefit of Frome, to include 300 new homes (including 72 affordable homes), at least 45,000 sq ft of employment / community floorspace, and high-quality public realm. It would also use innovative building methods because of the site challenges.

It was clear, unfortunately, that the other developers were most likely to pursue an unremarkable housing estate approach, failing to acknowledge the diverse heritage and range of buildings, with the result that a generational landmark opportunity would unfortunately be missed. It was for this reason that the Council entered into the sale and overage agreement with Acorn (this is, in essence, a legal agreement under which the land will be sold to Acorn in phases once satisfactory detailed planning consents are obtained - and certain other important preconditions met - with the ability for the Council to participate in super-profit if the project performs beyond expectations).

The sale and overage agreement will be determinable, without cost to the Council, if Acorn are unable to obtain detailed planning consents and it was heartening to note the significant pre-application consultation undertaken by them demonstrated that there was major support for their proposals: this was clearly reflected in the Local Planning Authority's resolution to grant an outline planning consent for the project not just once but twice.

This statement does not comment on the merits of other proposals, as it will be for the Local Planning Authority to determine whether any of them presents a deliverable scheme which is acceptable in land use terms, addresses evidenced lack of provision of the facilities included in it, and complies appropriately with the provisions of the Local Plan, all of which the Acorn scheme clearly does.

Future Somerset Council 'on track' for success

Highlights from the fifth Advisory Board Meeting, held virtually via Microsoft Teams 03.02.22

A unitary Council for Somerset will be in place in just over 12 months. Preparations are ramping up to ensure residents continue to receive the local services they rely on from day one, on 1 April 2023.

Some 350+ services currently run by the five Somerset councils (the County Council and four District Councils), will be delivered by a single, new authority.

So what needs to be achieved in the coming weeks and months ahead, and how will the new Council work?

To answer those key questions, step forward the new Local Government Reorganisation (LGR) Programme Director, Alyn Jones. Addressing an audience at the February LGR Advisory Board, he said: "We've a huge programme of work to do, and we must now motor-on through every aspect of our business case.

"Timing is tight, but we're energised, and we're on track."

A blueprint is being drafted which will set the direction of travel for the new local authority, and outline the aspirations, opportunities and benefits that a single Somerset Council will bring to the county's residents, communities and businesses.

Alyn Jones said: "We must set a strong budget, identify and prioritise 'must have' projects, while also ensuring the all-important County Council, city, town and parish elections, take place in May."

More than 130+ people attended February's virtual Advisory Board. The meetings provide an informal environment in which residents, councillors, public sector partners and other interested groups can feed in to the new Council process and share ideas about the shape of the future Somerset Council.

LCN pilots push on

Also on the Advisory Board agenda this month were Local Community Networks (LCNs). Three LCN pilots are under way across Exmoor, the Frome area, and in the Wincanton, Castle Cary and Bruton area. Guest speakers from each pilot gave presentations on their progress to date, and answered questions.

LCNs will be 'committees of the council' with powers, including spending. They'll shape policy and take action to improve their local area. It's envisaged up to 20 LCNs will be established on April 1st, 2023, consisting of residents, councillors, town and

parish councils, community groups and partners such as the NHS, education, and the Police and Fire Service.

Discussions around LCN boundaries will be the next big conversation. Options for initial consideration go out to consultation during summer 2022, with geographies (lines on maps) finally agreed by year end.

Communication matters

LGR Communications Lead, Steve Coomber, wound up the two-hour session with a communications update. He reported that crucial messages about the May elections, the biggest and most significant in Somerset for many years, will be going out to encourage residents to vote, and candidates to stand. And as the LGR programme shifts to 'implementation stage', residents will be hearing much more about the vision and culture of the new Somerset Council, the service approach, plus benefits.

Next meeting

The next meeting will be held in person on Thursday, 17 March 2022, 4.30pm at Williams Hall, Dark Lane, Stoke St Gregory, Taunton TA3 6EU.

National issues and campaigns to be aware of ...

Living with COVID-19 - useful link

The government has published its plan for living with COVID-19. This means:

- You are no longer be legally required to self-isolate if you test positive for COVID-19. New guidance will advise people who test positive to stay at home and avoid contact with other people.
- You are no longer legally required to self-isolate if you are an unvaccinated close contact and will no longer be advised to test for 7 days if you are a fully vaccinated close contact.

The current set of 'Working Safely' guidance for businesses will be replaced with new public health guidance on 1 April. As with other infectious diseases, there will continue to be actions that the employers can continue to take to reduce the risk to their staff and customers.

HMPO Passport Turnaround Times

Applicants should allow up to 10 weeks when applying from the UK, to plan ahead and check passport expiry dates in advance of any planned travel.

It costs £75.50 to renew or replace your passport if you apply online or £85 if you fill in a paper form.

You must be aged 16 or over (or turning 16 in the next 3 weeks) to get an adult passport. There's a different process to get a passport for a child.

There are different ways to <u>renew or replace your passport if you're outside the UK</u>. How long it takes

<u>Check how long it will take to get a passport</u> before you apply. It takes longer to apply by post than online.

If you need a passport urgently, you can <u>find out more about the Online Premium or</u> <u>1 week Fast Track services</u>.

Do not book travel until you have a valid passport - your new passport will not have the same number as your old one.
